### Format and Deadlines

- Submit an electronic copy of the complete manuscript by <u>15 August</u> <u>2010</u> to the Conference Secretariat. Unless specified below, guidelines and style for full paper preparation should follow those of the Journal of International Business Studies. (JIBS, http://www.jibs.net).
- 2. Papers should be no more than 20 pages or 5,000 words in length, with an abstract of no more than 100 words.
- Acceptance notification will be sent by <u>10 September 2010</u>. The Conference Secretariat must receive final revised manuscripts, by <u>30</u> <u>September 2010</u>.
- 4. The author(s) must certify that the accepted paper is not copyrighted and has not been published elsewhere.
- 5. Papers will be arranged for presentation and publication ONLY if at least one of the authors registers for the Conference by the registration deadline, *30 September 2010*.
- 6. An individual author may not appear on more than three papers.

# Conference Proceedings

Papers will be double-blind reviewed for publication in the Conference Proceedings. Accepted papers will be included in the Conference Proceedings only if the authors register with the Conference by the deadline.

# Official Language

Papers and presentations should be in English.
